Reisig Historic Preservation Grants

Pam Reisig, member of the Major Elijah Hyde Chapter, passed away August 14, 2019. Pam's family, including KSDAR member Heather Reisig, established a memorial fund in Pam's honor to be directed to KSDAR to support these one-time local historic preservation project grants.

Congratulations to the winners of the \$300 Reisig Historic Preservation grant competition. The winning chapters are:

- · Eunice Sterling Chapter, Southwest District
- General Edward Hand Chapter, Southeast District
- · Polly Ogden Chapter, Northwest District
- Olathe Chapter, Northeast District

These chapters were up against some fierce competition as many wonderful projects were submitted. In fact, it took our judges a while to reach a consensus on some.

The winning projects are:

- The restoration of a monument placed by the chapter in 1923 to commemorate a Peace Treaty signing with several tribes of Plains Indians that took place nearby in 1865. It had been moved back from the road, and the base is cracking.
- The restoration of the "DAR Pillars" at the entrance of the Ottawa Indian Cemetery in Ottawa, Kansas.
- Installation of an historical marker on the Manhattan Linear Trail to mark what is commonly known as the "Griffing" site. The proposed marker recognizes the site of a series of early Indigenous farmsteads along a stretch of Wildcat Creek in present-day Manhattan, Kansas.
- Replace the DAR Santa Fe Trail Marker at the Mahaffie Stagecoach Stop and Farmstead that had to be removed in 1988.

These chapters will receive their grant monies by the end of December 2020, and KSDAR will strive to offer tools to ensure their project receives great public relations and outreach.

Although only four winners could be selected, each of the 14 projects was deserving of historic preservation, and chapters are strongly encouraged to follow through with their projects, even if they have to cut back and take smaller steps toward completion.

A sincere thanks to all who participated.

Metzger Administration Welcome Pg. 2 Home Grants

The Metzger Administration will once again be awarding "Welcome Home" Grants in 2021. Chapters may apply for grant funds that support projects that Welcome Home our Nation's veterans and current service members – whether a physical home or the home that is created through healing and purpose. Additionally, chapters may sponsor an organization applying for grant funds that directly support veterans and current service members.

These grants to benefit veterans and current service members are only available because of the generous support of Kansas Daughters to the State Regent's Project. The Grant application deadline is March 15, 2021. Chapters and chapters sponsoring organizations receiving grants for projects will be notified by April 15, 2020. Grants in amounts between \$500 and \$2500 will be awarded. The Grant Application and the Grant Application Instruction Sheet can be found on the KSDAR members' website. Last year's grant recipient was the Robert J. Dole VA sponsored by the Flores del Sol Chapter who received a \$2,500 grant to assist Wichita homeless Veterans to move into permanent housing. With this grant, 10 queen size beds and platform frames were purchased along with 20 pillows and 10 bed in a bag linen sets. Karen Malcolm, a VA Voluntary Service Representative at the Robert J. Dole VA stated, "We are so grateful for this donation, we had four Veterans who moved into housing recently who were waiting on a bed and two more scheduled to move in this week! These items will go fast and were so needed – we cannot end Veteran homelessness without community partners like KSDAR. Thank you!!!!



Need a Helping Hand?

Kansas has had a surge in the number of Daughters that have trained to become Volunteer Genealogists in the past year. Due to this, we may be able to assign a DAR trained Volunteer Genealogist to a chapter needing assistance. Things that a Volunteer Genealogist might be able to assist a chapter with include:

- Assistance in clearing a current AIR (Additional Information Request) of a prospective new member who already
 has her application submitted. The team can help with supplemental AIR's as well.
- Additional training for a current chapter registrar on proper application processes. It is encouraged that all
 current registrars to sign up for the free online training class that was released in January 2020. Many things
 have changed in the applications process and this class will provide information and directions for the processes.
- Assigning a more seasoned Volunteer Genealogist with a less experienced registrar, to work one on one
 providing training on current standards of verification and support in completing new member applications.
- Guidance in how to effectively use the DAR.org website tools, such as webinars, Genie Clips, PMD (Prospective Member Database) and e-membership.
- Volunteer Genealogists are available to give a chapter program or workshop to prospect new members as well
 as providing training to current members on the GRS system and e-membership research. These may be virtual,
 due to the current pandemic situation.

Virtual Support Team

Balcony Volunteers, the expert help sessions at Continental Congress, went virtual this summer. The online sessions were a great success and because of this, the NSDAR Executive Board has approved the creation of the Virtual Support Team (VST).

The VST consists of members who have completed at least GEP I and II, or the previous courses. The volunteer genealogists and lineage researchers will be teamed with members and registrars by phone or video conferences. So, if you are asking yourself:

- Where do I find proof that she was his daughter or his wife?
- Does this count as residence or service?
- Do I have to use a BC or will this draft card work?
- Did I fill out this application correctly? With this new service you will have assistance to answer these and other questions.

New member applications will be handled by the volunteers of the Lineage Research Committee. The Volunteer Genealogist Committee will assist with supplemental applications. The intent is to aid, not complete the applications. The National Vice Chairs will coordinate and share the pool of volunteers.

The VST will launch in January of 2021. If you are interested in volunteering but have not taken GEP I or II, there is still time to sign up and complete those courses. Project Patriot Thank You

I would like to thank each DAR Member and Chapter that worked on the Patriot Project – Christmas Cards for the Theodore Roosevelt. This was a short notice project and in true DAR fashion, our members exceeded my wildest expectations! The project was to collect 5,200 signed Christmas cards for the sailors, who will be deploying before the holiday season. It was a joy to work together on this project and talk with several members from across the state and hear how this was a "perfect COVID" project that allowed members to get back at doing what we do best. I was one of 12 coordinators from across the nation. KSDAR Chapters provided 3,097 cards - I received cards from

chapters. Our "Elf" aboard ship will receive a total of 33,737 cards to gift to our sailors, which means each sailor will receive a minimum of six cards! As a mom of one of the sailors on board the Theodore Roosevelt, I cannot thank KSDAR enough!



Chapter Electronic Meetings Bylaws Verbiage

With COVID came the need for chapters to adjust their meetings to online formats, however, due to bylaws limitations, it has been difficult for many chapters to conduct business electronically this year. Many chapters have been working on bylaws language to make this process easier to navigate. Laura Kaiser, KSDAR Bylaws Chair and Shawnee Mission Chapter Regent, has shared its newly adopted bylaw amendments pertaining to electronic meetings. She wants to remind everyone that these were written for their chapter, and that every chapter is different. It is important that chapters adopt amendments that work for their needs.

Proposed Amendment #1

Amend ARTICLE --- Meetings by inserting a new Section -. Electronic Meetings.

Except as otherwise provided in these bylaws, meetings of the Chapter may be conducted through the use of electronic meeting services designated by the Regent. Electronic meeting(s) may be called by the Regent or three (3) officers. These electronic meetings of the Chapter shall be subject to all rules adopted by the Chapter, to govern them, which may include any reasonable limitations on, and requirements for, Chapter members' participation. Chapter members may join in-person meetings virtually. Their presence will count as if they were there in person.

The current Section - will be renumbered Section -.

Proposed Amendment #2

Amend ARTICLE --- Executive Board, Section - by adding:

The Executive Board is authorized to hold electronic meetings. Members who are not present in person may be permitted to participate electronically, whereby all members can simultaneously hear each other and participate.

Proposed Amendment #3

Amend ARTICLE - Committees by inserting Section -.

Electronic Meetings: The committees are authorized to hold electronic meetings whereby members participating can hear each other simultaneously.

And renumbering the current Section - to Section -.

Chapter Model Bylaws

If your chapter has not reviewed its bylaws, now may be the time to refresh them. NSDAR provides chapters with the Chapter Model Bylaws document that has required language (in bold print), and suggested language. It is important for chapters to review their bylaws annually and compare it with the Chapter Model Bylaws to ensure that required language is incorporated and that any other changes are made in a timely manner. State Parliamentarian Lyn Patterson, parliamentarian@kansasdar.org, is available to assist chapters with their bylaw questions.

Gift Cards Fill Needs for Haskell Students



Thanks to Kansas daughters, comprising 31 separate donations and representing 16 chapters, Haskell students will be gifted with 69 gift cards. And, what a wonderful way to honor these Native students during Native American Heritage Month!



I drove to Lawrence on Saturday, November 21 to deliver 61 gift cards to Manny King, Haskell Student Life Director, just in time for Thanksgiving. Since that date, I have received additional donations of eight more cards, accounting for the 69 total cards. These additional cards will be sent to Manny after Thanksgiving. And since Haskell also received donations of turkeys for these students, Manny was able to deliver our gift cards with the turkeys in time for Thanksgiving. Given the remote learning model in place this semester, many students have struggled with support at home. According to Mr. King, more and more students are continuing to return to Lawrence, especially given the recent rise of Covid-19 cases throughout Native communities across the country. Many students will be remaining in Lawrence throughout the holidays to minimize spread of the virus back home, as well as to ready themselves for the Spring semester, which will continue to be conducted through online learning. Manny expressed his gratefulness for the gift card donations because many will be helpful for newly arriving students who will need basic necessities as they set up their living situations.

Preparing Outstanding Commemorative Events Reports

Information in the reports must include the type of event, date of the event, details of the program, and publicity. Please read through this carefully as some of the rules and dates have been changed.

- A theme folder with a clear cover must be used for each entry. A 3-Ring Binder will be disqualified. Limit of 25 pages including photos. Pages must be 8 ½ x 11, one-sided, size 12 type, using Arial or Times font. The folder must not exceed ½ inch thickness.
- A submission form must be attached to each report. Make sure the form has been fully completed by the chapter and signed by the State Chair. Hard copies only should be submitted. Digital photos of each event are to be emailed in addition to the report folder. A quality copy of the report may be sent if the chapter would like to keep the original.
- January 15th: Chapters should send Outstanding Chapter and State Reports plus photos, to the State Chair. The reports will be judged and First Place winners are sent to the National Division Vice Chairs.
- March 15th: The Commemorative Events Vice Chairs will do the final judging for National Awards.
- All other reports will be returned to the State Chairman if they include a mailing envelope with pre-paid postage.
- The awards for Outstanding Reports at the National Level will be 1st, 2nd, and 3rd Place. Division Awards will be sent out ahead of time and only National Awards will be awarded at Continental Congress.

Thanks to all of you for your time and effort in this most important committee.

speaker, but the Chapter Regent should
thank him/her at the close of the
presentation.

Q. May I wear my insignia with a pantsuit? **A**. Yes, you may wear your insignia with a pantsuit but it is not appropriate to wear the sash with pantsuits.

Treasurer Deadlines

Chapter dues were due to NSDAR
Treasurer General and the KSDAR State
Treasurer on December 1, 2020. Members
that send their dues after this date are late,
but they can still be sent to NSDAR and
KSDAR.

Other important deadlines for chapters include:

- Chapter Master Report (CMR) is due before February 1, 2021.
- The chapter annual report must be sent to the State Treasurer by March 1.
- Chapter IRS Filing is due by April 1. Form 990, 990-EZ or 990-N must be filed each year. If a chapter does not file, they could lose their tax-exempt status.




A Message from our KSDAR Chaplain
