129th Continental Congress in Review

The 129th Continental Congress was a resounding success with viewership reaching over 20,000 of the opening night session. By having Congress solely online due to the pandemic, many Daughters were able to participate that would never be able to attend in person.

It is amazing to realize that the entire production of the Online Congress took only two months to organize, produce and air. The President General had a clear idea of what she envisioned and through the work of 100's of employees and Daughters the first ever virtual Continental Congress was conducted!

DAR Insignia Store

The DAR Insignia Store began operation during Continental Congress at shop.dar.org and quickly proved to be a great success. Because of the pandemic, the store had limited pins available due to the American manufacturers shutting down, but Daughters understood the situation and quickly shopped the available pins. Kansas's own Kathryn West, Corresponding Secretary General, was tasked with the development of this major endeavor and she and her team made it an amazing launch! Now the purchase of DAR insignia and pins will provide more funds for DAR projects. Mrs. West and several Kansas Daughters presented an Insignia Commercial during congress that showcased some new products and made Kansas proud!

Several new pins were debuted at Continental Congress including the new President General's Donor Pin, the MIA/POW pin, the Women's Vote pin, and the America 250 pin. National Historic Preservation Award

Completed in 1920 for Wesley Hospital as a summer facility for at-risk infants, the Fresh Air Baby Camp was constructed with financial donations and volunteer labor. Hospital nurses operated it for six years, and it is believed this is the last remaining free-standing structure built as part of a national movement to restore the health of "failing" infants by exposing them to fresh air in a safe environment.

The local Girl Scout Council leased the building until 2001 for use as a Little House, but, upon their departure, the facility declined from lack of maintenance.

The Friends of the Historic Fresh Air Baby Camp have spent the last 10 years raising money, soliciting in-kind donations and grants, and hundreds of hours of physical labor to restore the building in an historically accurate manner. They have succeeded beyond all expectations.

I nominated them for the National Historic Preservation Award and was pleased to present it to them as they truly deserved the award. They were so proud and happy to be honored by DAR for their efforts.

Filling out the application form and collecting the necessary documents and pictures for the award was time-consuming, but the end result was well worth the efforts.

As KSDAR Historical Preservation Chair, I urge chapters to consider honoring a local person or group who has worked or still is working on an historical preservation project. Such efforts need our support. Go to the DAR Members page, Committees tab, and click on Historic Preservation. There you will find information and forms for awards and other honors your chapter can present. You will also find links on the KSDAR website, within the SIP tab.

Honoring someone with an NSDAR Historic Preservation Recognition Award will also help your chapter gain positive recognition for DAR. Our city newspaper never covers DAR events, however, two main TV stations sent reporters as we were able to gain the attendance of the Kansas Lt. Governor, our state senator, a state representative from the district surrounding the Fresh Air Baby Camp, plus the Mayor and Vice Mayor.

NSDAR Legacy Designation



DAR has introduced a new "Legacy" status for relatives who use the same ancestor to join DAR. 
State Regent's Project Merchandise

Audrey Bebermeyer Awarded Richard and Elizabeth Dean NSDAR Scholarship

The National Society of the Daughters of the American Revolution offered 26 academic scholarships all across the United States that include general scholarships as well as those that target specific fields of study. The DAR national scholarships are extremely generous, but highly competitive, according to a DAR member who served as a 2020 judge for the Richard and Elizabeth Dean Scholarship, the most prestigious scholarship offered. The Dean Scholarship is for \$20,000 over 4 years of study. Only two high school seniors are selected each year. Over 2,700 students applied for the Dean Scholarship this year.

Audrey Katherine Bebermeyer, Valedictorian at Chaparral High School in Anthony, KS received the honor of being awarded the Richard and Elizabeth Dean Scholarship. In addition, she received the KSDAR Scholarship and the Martha Vail Good Citizens Scholarship. Audrey will be a freshman at Wichita State University

where she will pole vault as a member of the WSU Track and Field Team. She will begin WSU as a sophomore in Communication Sciences and Disorders in route to become a candidate for PhD in Speech-Language Pathology.

According to Dee Saddler, Martha Vail Regent, Audrey is the newest member of the chapter. Audrey comes from a long line of Martha Vail members with her great-great- grandmother Florence Galloway Mueller serving as chapter regent from 1951-1953. Audrey's mother Jennifer Cox and grandmother Lee Cox are also proud members of Martha Vail Chapter NSDAR.

Protocol 101 - What's In a Name?

You may wonder how chapters get their names and what are the rules surrounding naming a chapter. From section 15 in the NSDAR Handbook which can be purchased from the DAR Store or found on the DAR Members website. The describes chapter naming rules:

- (a) Names of chapters located in states admitted to the Union before 1825 shall be confined to the period preceding 1825 and preferably to historic events, geographic sites or individuals relating to the American Revolution. Chapters located in states admitted to the Union after 1825 may be named for territorial historic events, geographic sites or names of prominent early area pioneers.
- (b) Chapters located outside the United States shall be named for historic events or individuals representative of the period of the American Revolution or for geographic sites.
- (c) Chapters which may be located in military installations may be named for the military installation.
- (d) A chapter shall present three proposed names to the Organizing Secretary General who shall submit the recommended name to the National Board of Management. After a name has been officially granted, it shall not be changed by the chapter unless permission is granted by a two-thirds vote of the National Board of Management.
- (e) No chapter shall adopt the name of a chapter in existence.
- (f) A chapter may adopt the name of a disbanded chapter, provided permission is granted by two-thirds vote of the National Board of Management.
- (g) No chapter may use the name of a historic property owned by a state organization of the Society or by another chapter of the National Society of the Daughters of the American Revolution.

ALL this and more can be found in your NSDAR Handbook.
