Dear Kansas Daughters,

Last month I returned to our NSDAR Headquarters in Washington, DC for the first in-person National Board of Management meeting since February 2020. What a joy it was to see our beautifully restored Constitution Hall and spend time with fellow State Regents. A highlight of the trip was the rededication and 100<sup>th</sup> year commemoration of the placement of the cornerstone of the Administration Building. Our own Sarah Mitchell Guernsey, 9<sup>th</sup> President General and Kansas Daughter, attended the original ceremony in 1921 and called the cornerstone a "steppingstone" to the future of our organization.

Last month also brought the opportunity to visit the Mission Hills, John & Hattie Possum, Ephraim Basehor, and Tomahawk Chapters. These chapter visits, spending time with members and learning about their local activities and service, is one of the best parts of serving as State Regent.

Recently, each chapter regent received an email from the President General regarding a special meeting of Continental Congress to be held on December 8, 2021, at our NSDAR headquarters. Eligible voters will be asked to consider authorizing the Executive Committee, in collaboration with the American Battlefield Trust, to modify the DAR Pathway of the Patriots project, including, but not limited to, relocation to, or near, an alternate Revolutionary War site. The Special Meeting is open to the entire Society, and non-voting members are also welcomed to attend. The meeting will be followed by a festive Members Only Holiday Open House at our headquarters Additional information can be found in the President General's blog.

As we approach Thanksgiving, I wish to express my deep gratitude for all Kansas Daughters for this privilege to serve as your State Regent and for all you do to bring the mission of DAR to your communities. Thank you.



The groups then toured the library, museum, period rooms as well as the President General's Reception Room. A lunch in the banquet hall was followed by stepping out onto the Portico deck to view the Washington Monument. The visit was capped off by shopping in the DAR Store and pop-up Insignia Store. The group then departed to the new Dwight D. Eisenhower Memorial where a remembrance ceremony was held, and a wreath was placed. Later that evening the Kansas Delegation held a group dinner. Our House Beautiful is truly an amazing place!



## NSDAR Special Meeting and Open House December 8, 2021

Recent developments have prompted the National Board of Management to authorize the President General to call a Special Meeting of our National Society on December 8, 2021, in conjunction with a festive <u>Members Only</u> Holiday Open House at our headquarters. Below is information to explain why this session has been called, what will be necessary to conduct the specified business in the official Call to Meeting and why eligible delegates are encouraged to participate.

The primary and urgent purpose of the meeting is to consider modifying a motion that was adopted by the 127<sup>th</sup> Continental Congress that established the DAR Pathway of the Patriots, which proposed to create a gift to the nation of 250 trees honoring Revolutionary War Patriots along the Schuylkill River in Pennsylvania. Delegates to the 2018 Continental Congress approved the proposal to partner with the Pennsylvania Horticultural Society (PHS) and USA250 on this project. Generous Daughters purchased all 250 trees within a year, reserving the naming rights in honor of a Patriot of their choosing.

In the meantime, USA250 was absorbed by a new organization, Philadelphia 250, and the Pennsylvania Horticultural Society had a change in leadership. And then, of course, the pandemic slowed everything. Regrettably, after more than three years of planning, a formal agreement of understanding has yet to be finalized amongst the organizations.

Complexities make working with PHS and Pennsylvania 250 exceptionally challenging. Approvals must be obtained from each of the municipalities/property owners along the 27-mile pathway. Further, Philadelphia 250 and the City of Philadelphia now require approval of all wording on not only all project signage but also our DAR website. These approvals have yet to begin and would add significant time to moving forward in a timely manner. Simply put: The project is stalled in its current location, and – out of respect for our generous supporters – we felt it in the best interest of the DAR to consider alternative locations and partners.

DAR believes that the American Battlefield Trust, a well-respected organization that has saved more than 53,000 acres of historic battlefields, is a preferable partner. Preliminary conversations with Trust officials regarding the possibility of working to locate the DAR Pathway of the Patriots at or near another Revolutionary War site have begun. Following initial conversations, the Trust has indicated that it can, indeed, provide an appropriate location for our project, one that would have a single property owner and more extensive interpretive signage. Further, a Trust site would have a built-in audience of thousands of visitors annually. These sites will draw increased attention as we draw nearer to 2026 as Americans and international visitors alike journey to the places where our revolutionary history happened.

Eligible voters will be asked to consider authorizing the Executive Committee, in collaboration with the American Battlefield Trust, to modify the DAR Pathway of the Patriots project, including, but not limited to, relocation to, or near, an alternate Revolutionary War site.

As the original DAR Pathway of the Patriots motion was voted on at the 127<sup>th</sup> Continental Congress, a Special Meeting of that same body, the National Society, is needed to amend the ruling. As per our bylaws, the National Board of Management authorized this Special Meeting to be called in December so that the project can continue to move forward immediately, rather than waiting until the next Continental Congress in June 2022 for a vote. Delegates cannot meet via an electronic platform to cast their ballot remotely because there is no longer a declared emergency in Washington, D.C.

The Special Meeting will be conducted on December 8, 2021, 6:00 p.m. ET, at DAR Constitution Hall. According to the National Bylaws, the members who served as delegates and alternates at the 130<sup>th</sup> Congress will be the official credentialled delegates for this Special Meeting, along with the new officers who qualify for an automatic vote. *All eligible delegates will receive a detailed email in the coming days with information to register as credentialed, voting members of the Special Meeting.* Please note that there is not a DAR block of hotel rooms at the JW Marriott for this Special Meeting in December but there are many hotels in the area for out of town attendees.

The National Board of management also recommends amending two national Standing Rules. If the amendments are adopted, the registration process for Continental Congress may be conducted through methods other than the U.S. mail. The only business that may come before this Special Meeting is the business stated in the official Call to Meeting.

Per the National Bylaws, 150 eligible voters constitute a quorum to conduct business at a Special Meeting of the Society. All qualified voters who are able to attend this historic Special Meeting are requested to do so, in order that we may meet the quorum requirements.

May other (non-delegate) members attend the Special Meeting? Yes – and please! The Special Meeting is open to the entire Society, and non-voting members are also welcomed to attend. However, note that ALL voting and non-voting members must pre-register -- pre-registration is required and due no later than December 1, 2021. Non-voting members should pre-register to attend the Special Meeting via this link: https://www.dar.org/members/special-meeting-non-voter-rsvp. Please note that the Special Meeting is for members only, and that no spouses, children or other guests will be admitted.

A members-only wine-and-cheese reception and holiday open house, with festive décor on display throughout our House Beautiful, will immediately follow the Special Meeting. There will be no public open house this year.



#### How does a Chapter get involved in the contest? I'm so glad you asked!

Any person able to hold a pencil, crayon, marker, or paintbrush is eligible to enter. All DAR members are encouraged to participate. Consider involving CAR, homeschool, scout, church and public school groups. The poster should illustrate the spirit or meaning of the U.S. Constitution.

A complete explanation of the rules and entry forms can be found on the DAR Members website under Constitution Week, Contests. It is important that the contest rules are followed exactly. Kansas was unable to submit any entries last year due to rule violations. Please note, paper



must be 11" x 17" and <u>must have a signed entry form attached to each submission</u> (for entrants under 18, a parent or legal guardian MUST sign). The winning poster, as judged by National, will be printed and available for sale in the DAR Store.

All KSDAR entries (originals only) must be mailed to this Chair and postmarked by January 15, 2022. I look forward to seeing your amazing talents on display!

# Captain Jesse Leavenworth Chapter Day of Service Project

Under a beautiful blue sky on a warm and welcoming day in Wichita, the two of us and our sister Roberta Beaver Hoffman, also an Arizona Daughter, were joined by members of the Martha Loving Ferrell Chapter and two Kansas state officers to dedicate a DAR grave marker in honor of our grandmother, Grace Adams Frost Kincaid, a former regent of Martha Loving Ferrell Chapter.

For several years we three sisters had wanted to honor our grandmother who was our inspiration for joining DAR, then COVID got in the way! As this past summer rolled around, and with the availability of the vaccine and facing the reality that we aren't getting any younger, we decided this was the year no matter what! With the approval by grandmother's chapter, we ordered the marker, and we invited the chapter to participate in the dedication. Then, there was an uptick in COVID infections.

By the time we arrived in Wichita, all we knew is that chapter regent Linda King and State Officers Patti Unruh, and Lee Cox planned to join us on October 6, for the short dedication ceremony. You can imagine our surprise and delight as car after car kept pulling into the cemetery!! The members of Martha Loving Ferrell really came through for us despite the pandemic! Regent Linda King and Assistant Chaplain Pat De Voss joined the three of us in the ceremony.

We three "Beaver girls" reminisced and told stories about our Grandmother Bobby aka Grace and our wonderful times with her in Wichita. We wanted today's chapter members to know just what kind of woman and Daughter she was! Bobby was a very prim and proper lady. She was a consummate cook, and her scrapbook tells that she was involved in many DAR activities where food was key whether it be for a fund raiser or social event (was this our grandmother's DAR!!). She collected antiques, made quilts, hooked rugs, and loved singing to us as we swung on her porch swing.

Bobby had joined Randolph Loving Chapter in 1936 and she transferred to Martha Loving Ferrell when it organized in 1937. We always heard the story of our Revolutionary War Patriot William Spencer of Pennsylvania who served as a drummer boy! She took pride in knowing her family supported the cause for independence. Bobby was installed as chapter regent in 1961 (we don't know why it took so long!) and she was in that position at the time of her death in 1963.

We are so thankful for the time we had in Wichita with the Kansas Daughters. In fact, we loved it so much that Martha Loving Ferrell now has three new associate members. Our heartfelt thanks goes to everyone who helped make this such a special occasion for us including former chapter vice-regent Donna Berner who was our original contact with the chapter.

#### Women's Issues Essay Contest

The theme for the 2021-2022 VanBuren Administration Women's Issues contest is "Managing Life's Complexities During the Pandemic". The essays may be written and submitted under one of the three categories: Career, Family or Health. Examples:

CAREER: How has your professional life been affected in the last year? Have you been successfully balancing family needs, personal needs and job requirements? Do you foresee obstacles to returning to your "normal" work schedule as the world reopens? If your business or workplace has permanently closed, do you have a plan of action? Is it possible that the pandemic has had a positive effect on your work or attitude?

FAMILY: How has the pandemic affected your relationships with your spouse, with family members you could not visit or with family members with whom you had to live with every minute of every day? How have family duties been shared? Has your family developed new ways to have fun and enjoy each other?

HEALTH: The pandemic and resultant quarantine have taken a toll both physically and mentally. How has this year affected you and your family? Have you developed a "secret weapon" to combat isolation or anxiety? How have you managed to stay physically strong and fit? What successes can you share as we all strive to maintain a healthy body and spirit?

Share your experience in relation to family, career or health through essay writing. Only one essay per member per year will be accepted. No attachments or pictures to the essay will be accepted. Essays must be electronically sent to the State Chair of Women's Issues Committee by her deadline.

The essay must be typed as a Microsoft Word Document and no longer than 1800 words. The first page of the essay will be a Cover Page containing the items listed below. These words do not count in the 1800 word limit. The "Essay Contest Entry Form" must accompany the Essay. Judging begins on the State level. State winners progress to the Division Vice Chairs to be judged among the states in their Division. The Division winners of each Division progress to compete on the National Level in their stated category. Essays are judged on:

All entries will be judged on the State, Division and National levels by at least three non-DAR judges. The State winner's essays in each category will be sent electronically to the respective Division Vice Chair by February 15. The Division winner's essays in each category will be sent electronically to the coordinating National Chair of Family, Career or Health before March 15. The National winners for each category will be notified before Continental Congress.

Our goal is to have a "winner" in all three categories from each state. If you have any questions, please reach out to me. Thank you!

# Volunteer Awards

Do you know an outstanding volunteer in your community or your chapter? DAR Service for Veterans has three award categories to consider.

- Outstanding Veteran Volunteer Award presented to a veteran in recognition of outstanding achievement in personal, professional, and family life. Applicant must prove significant contributions of leadership, patriotism, and increased public awareness of veterans. The sponsoring chapter must be in the state where the veteran lives.
- 2. Outstanding Youth Volunteer Award presented to a youth volunteer who provides service for veterans and is 14 to 21 years of age. The award is given in recognition of outstanding or unusual care given to veterans. The candidate for the award serves as a role model for peers and consistently demonstrates the qualities of leadership.
- 3. Outstanding DAR Service for Veterans Award presented to a DAR member in recognition of outstanding care given to veterans in any of the following areas: Department of Veterans Affairs facilities, state veterans facilities, nursing homes, shelters, and outpatient clinics. The outstanding NSDAR volunteer has given more than her time. She has made meaningful contributions to veterans through creative and resourceful outreach.

The DAR Service for Veterans State and National Award Winners may now be presented medals for their awards along with certificates. Please contact the DAR Store to purchase the medals. These medals are available to State and National award recipients that have received the DAR Service for Veterans Awards.

# Commemorative Events



# Outstanding Teacher of American History



The Outstanding Teacher of American History Contest honors notable full-time teachers of history (and related fields such as social studies, government, and citizenship education) in public, private, and parochial schools, grades 5-12. These teachers have demonstrated excellence in:

- Readily sharing an incisive knowledge of American History.
- Being committed to their students.
- Fostering a spirit of patriotism and loyal support of our country.
- Relating history to modern life and events.
- Requiring high academic standards at all times from their students.

Every chapter is encouraged to select and recognize an Outstanding Teacher of American History in the local community. Chapter winners may be presented a free chapter winner certificate. Additional suggestions about how to honor a chapter winner are offered in the Historian General's Form section or from the Office of the Historian General. Instructions for nominating a teacher for the 2021 NSDAR Outstanding Teacher of American History Contest and the official application are available in the National Information Packet and linked under the State Historian on the KSDAR Member's website (www.members.kansasdar.org; under the SIP tab). The chapter winner's application and supporting materials should be submitted to the KSDAR American History Chair Laurie Barnes no later than November 15, 2021.

The state winner will be presented a winner certificate, special pin, and \$250 award. The state winner is eligible to participate in the NSDAR national competition. State winner winner's application and supporting materials will be forwarded to the Historian General for consideration in the National contest. The national Outstanding Teacher of American History is honored at Continental Congress and receives a monetary award of \$3,000, a special certificate, and a book.

#### Constitution Hall Marker Dedication

Topeka Chapter dedicated two new DAR historic markers at Topeka Constitution Hall during Constitution Week, on September 18, 2021. Special guests attending the event were State Vice Regent Rebecca Geist Kline, Topeka Deputy Mayor Padilla, Sarah Tenfel deDubois of the Kansas State Library and Dr. & Mrs. Charles Robinson, the first Governor of Kansas (played by reenactors Suzanne and Steve Germes). Chris Meinhardt, project coordinator for Friends of the Free State Capitol, owners of the building, provided an historical perspective of Constitution Hall which was added to the National Register of Historic Places in 2008. The building is a National Underground Railroad to Freedom site and partner in Freedom's Frontier Heritage Area. Phase one of the restoration of the building is almost complete.

Jan Stegelman, Topeka Chapter Historic Preservation Committee chair provided the history of the DAR Marker. The large marker is a replica of a marker that was dedicated at Constitution Hall on July 4, 1903 by Miss Zu Adams, a Topeka Chapter DAR Founder, and a Director on the Board of the Kansas State Historical Society. This original marker was first installed in the sidewalk in front of the Hall and was later mounted on the building. It was lost some time in the 1990s during building ownership changes. It reads:

CONSTITUTUION HALL
WHERE THE TOPEKA CONSTITUTION CONVENTION
MET IN 1855
AND THE
TOPEKA LEGISLATURE WAS DISPERSED
BY COL. E.V. SUMNER
JULY 4, 1856

The second marker commemorates the marker re-dedication.

Attendees were able to go inside the partially restored building with Chris Meinhardt, who provided information about the restoration process.

"The dedication of the Constitution Hall Marker is the result of the Topeka Chapter working together with the community. The Topeka Chapter DAR, Topeka Community Foundation, and Friends of the Free State Capitol provided funding and support for the project. It not only highlights the ongoing historic preservation project at Constitution Hall but also preserves a very important part of the history of Constitution Hall – the commemoration of the Hall by the Topeka Chapter of DAR in 1903. I am so pleased that both markers are installed in time for the first open house of the newly restored Constitution Hall currently set for late October." said Jan Stegelman.


